**The Wales Rod and Line (Salmon and Sea Trout) Byelaws 2017**  
**The Wales Net Fishing (Salmon and Sea Trout) Byelaws 2017**

I am writing to you regarding the Inspectors report following the inquiry that opened on 15<sup>th</sup> January 2019.

As previously advised the appointed Inspector will submit his recommendation on the proposed Byelaws in the form of a report to the Welsh Ministers. The Welsh Ministers will make the final decision on whether or not to confirm the proposed Byelaws.

At the inquiry the appointed Inspector informed the parties that his report would be submitted to the Welsh Ministers around 17<sup>th</sup> May 2019, however the Inspector stressed that this date may alter slightly due to the nature of the inquiry and resultant reporting time.

Therefore, I wish to inform you that due to the complexity of the case the Inspector has requested additional time to complete his report. It has been agreed with the Welsh Government that the Inspectors report will be submitted to the Welsh Ministers no later than Monday 3<sup>rd</sup> June 2019.

Please be aware that the Inspectors recommendation and the content of his report will not be made publicly available until after the Welsh Ministers have issued the final decision. The Welsh Government will be responsible for sending a copy of the decision to all parties. As such, once the Inspectors report has been submitted to the Welsh Ministers the Planning Inspectorate has no further involvement in the case.
